Urban Front Country Environmental Assessment

Project Framework:

The Urban Front Country Initiative was created to address the issues of recreational overuse and inconsistent regulations on public lands along the Front Range. Activities included in the Initiative that the Boulder Ranger District will be addressing as first priority are:

- · Recreational shooting
- · Dispersed camping
- Campfires

In Fiscal Year 2006, the Boulder Ranger District will review and update shooting regulations for the District and begin the assessment for dispersed camping and campfires as part of travel management and implementation of the OHV rule. At this time, we are gathering the issues surrounding recreation shooting (this excludes hunting), dispersed camping, and campfires on the Boulder Ranger District. Dispersed Camping and Campfires:


Natural Resource Impacts

How to Make Your Input Effective A Guide To Making Comments That Work

You Must Know:

- The type of Document being prepared
 - In the case of the Urban Front Country Project, an Environmental Assessment is being prepared
- Stage of the Planning Process
 - Initial scoping meaning public involvement
- · How the input will be used
 - To develop issues and then possible solutions to those issues

Your Comments should be:

- Specific
 - Address specific issues, statements, or inconsistencies
 - Describe your specific desires
 - Indicate what you support as well as oppose
 - Avoid moral or emotional appeals
- Clear
 - Isolate separate points in separate paragraphs or with bullets
 - Identify the offending statement, issue, or action
 - Describe the problems with the statement, issue, or action
 - Keep it simple
- Provide Information
 - Provide information as early in the process as possible
 - Provide or reference as much information as possible
 - Develop your own alternatives
- Request Action
 - In all cases, let the planners know what changes you want to see
 - Give them choices if possible
 - If you present new information, make sure to ask them to include it in the analysis
